Hinweise	Questions and answers on the ID card with online ID function (formerly: new ID card) 1. do I have to exchange my current identity card for the new one? • No, there is no obligation to exchange the card. A new identity card does not have to be applied for if the previous identity card is still valid, or an identity card in

the previous form was applied for before 01.11.2010, or a valid passport is available

2. can I exchange my current ID card for the new one, even though my ID card is still valid?

- Yes, since 01.11.2010 the ID card with online ID function can be applied for at any time, even if the previous ID card is still valid.

Do I need a biometric photo for the ID card with online ID function?

- Yes, a biometrics-capable photo is required (according to the photo sample board; new compared to the previously used ID card).

4. is the submission of fingerprints obligatory?

- No, fingerprints will only be taken if the applicant requests it for his/her own enhanced security.

5. is there any data that is only visible on the identity card and not stored in the chip?

- Yes, these are: Signature Size, colour of eyes Serial number

6. is there any data that is only stored in the chip and not visible on the ID card?

- Yes, these are on request: electronic signature 2 fingerprints

7. how is the address changed on the identity card with online ID function?

- The ID card authority puts a sticker on the ID card (as with the current ID card) and changes the address stored in the chip.

8. what to do if the identity card with online function is lost or stolen?

- The loss must be reported to the police or to a

passport and ID office in a municipality.

- If the online ID card function (electronic proof of identity) has been activated, you must arrange for it to be blocked, either at a passport and ID card office or at a blocking hotline (for further details, call the service number for the ID card). When blocking, the personal data and the blocking password must be given.

9. Can children also obtain the ID card with online ID function?

- Yes, if they wish. However, the online ID card function is disabled for children under the age of 16. However, this can be switched on at a later date from the age of 16. For children aged 6 and over, 2 digital fingerprints can be stored on request.
