The local authority is obliged to provide you with the requested information.</p> <p>For example, a development plan specifies the following for a building area,</p> <ul style="list-style-type: none"> <li>• how the land may be used,</li> <li>• which construction method the buildings must have,</li> <li>• what height the buildings may have.</li> </ul> <p>The development plan also includes, for example</p> <ul style="list-style-type: none"> <li>• Plan drawing consisting of various plans and maps showing the exact spatial division of the area,</li> <li>• Reasons with, for example, details of the decisions and considerations, and</li> <li>• an environmental report with an assessment of the impact of the development plan on the environment.</li> </ul>
