For example, a development plan specifies the following in text form for a building area: • how the land may be used, • what construction method the buildings must have, • what height the buildings may have. The development plan also includes, for example • Plan drawing consisting of various plans and maps showing the exact spatial division of the area, • Explanatory statement with, for example, details of the decisions and considerations, and • Environmental report with an assessment of the impact of the development plan on the environment. New or newly amended development plans can be viewed on the Internet. If the local authority responsible has not yet made the desired development plan available on the Internet, you can apply to the relevant authority to view the development plan.
