The local authority responsible for the local municipality or the body responsible for the procedure is obliged to provide you with the requested information.</p> <p>A land use plan</p> <ul style="list-style-type: none"> <li>• is a preparatory urban land-use plan and the basis for a development plan.</li> <li>• It has no legally binding significance. The intended urban development of a municipality is defined in the land use plan.
