Teaser	If you want to use the professional title "speech therapist", you need a license to do so. You can find out more here.
Volltext	The profession of speech therapist is regulated in Germany. This is regulated by law. This means that in order to work as a speech therapist in Germany , you must apply for a state license. With this permit, you can use the professional title "speech therapist" and work in the profession . The professional license is issued after passing the state examination or recognition of the foreign professional qualification if the health and personal aptitude (reliability) and the knowledge of the German language required for practicing the profession.
Erforderliche Unterlagen	<ul> <li>Copy of the certificate confirming that you have completed the training period prescribed by the relevant law and passed the state examination or notification of the equivalence of the foreign professional qualification</li> <li>(Police) certificate of good conduct: This is a confirmation that you have not been guilty of any behavior that would make you unreliable to practice the profession (does not have to be brought along, but only requested from the city administration) (not older than 3 months)</li> <li>In the case of a foreign professional qualification, extracts from the criminal records of all countries in which the applicant has resided in the last 5 years, if applicable</li> <li>Medical certificate stating that the applicant is not medically unfit to practise the profession (not older than 3 months)</li> <li>Confirmation that you have the German language skills required to work in the profession (certificate of</li> </ul>

Voraussetzungen	<ul> <li>You will be granted a license if you</li> <li>have passed the state examination for speech therapists after three years of training or your foreign professional qualification has been recognized in Germany,</li> <li>have not been guilty of any behavior that would make you unreliable to practice the profession,</li> <li>are not unfit in health terms to practise the profession and</li> <li>have the necessary knowledge of the German language to carry out the professional activities.</li> </ul>
Kosten	Is based on the respective administrative fee schedule of the federal state or on the fee statutes of the authorities responsible under federal state law.
Verfahrensablauf	You must apply for the permit from the competent authority. Once you have submitted the application and all documents are complete, the competent authority will check whether you meet all the requirements. If you meet all the requirements, you will receive the permit. You may only start working once you have received the permit.
Bearbeitungsdauer	The processing time varies. If the documents are complete, your application will be processed promptly.
Frist	There are no deadlines to be observed.

Hinweise	There are no indications or special features. Comparable training qualifications obtained outside Germany can be recognized as equivalent. If you have completed the relevant training outside Germany, you may be able to work as a service provider in Germany temporarily and occasionally without a permit (in accordance with EU law). You must notify the competent authority of this in advance.

Kurztext	<ul> <li>Permission to use the professional title of speech and language therapist Issue</li> <li>The applicant applies for permission to use the professional title "speech therapist"</li> <li>Only those who meet certain requirements are entitled to use the corresponding professional title. Permission to use the professional title is granted by the competent authority upon application if all requirements are met.</li> <li>The applicant must have completed 3 years of training and passed the state examination for speech therapists. In the case of a foreign professional qualification, an assessment of the equivalence of the level of training is required.</li> <li>Responsible: Depends on the respective state law</li> </ul>
