| Volltext                         | <ul> <li>Training in the field of psychological psychotherapy concludes with a state examination.</li> <li>Proof of passing the examination is a prerequisite for licensing as a psychological psychotherapist. Admission to the examination is granted on application.</li> <li>Training to become a psychological psychotherapist takes at least three years full-time and at least five years part-time.</li> <li>It consists of a theoretical part, practical training with patient treatment under supervision and self-awareness and concludes with a state examination. This comprises a written and an oral part.</li> </ul> |

| Voraussetzungen   | You can take the state examination if you have passed<br>a final examination in psychology at a university or<br>equivalent institution of higher education in Germany,<br>which includes the subject of clinical psychology.<br>Alternatively, you need an equivalent degree abroad<br>and full or part-time training at one of the<br>state-approved training institutes.  |
| Kosten            |  |
| Verfahrensablauf  | You must register for the state examination as a<br>psychological psychotherapist. To do so, use the form<br>prescribed by the state authority responsible for you.<br>Submit your application with the required documents<br>to the state examination office responsible for you.   |
| Bearbeitungsdauer | However, the candidate should be notified in writing of<br>the admission and the invitation to the examination<br>dates at least two weeks before the start of the<br>examination.   |
| Frist             | Following the reform of psychotherapeutic training,<br>training as a psychological psychotherapist can only be<br>completed by September 1, 2032, provided that a<br>course of study entitling the holder to participate in<br>postgraduate training was started or completed before<br>September 1, 2020. After September 1, 2032, only a<br>license according to the Psychotherapists Act of<br>November 15, 2019 can be obtained. The legal basis<br>does not provide for an explicit application deadline.<br>The competent authorities usually set an application<br>deadline of June 10 for examinations in the fall and<br>January 10 for examinations in the spring. The responsibility within the competent federal state is determined by the state regulations applicable there.</li> </ul> |
