Teaser	If you wish to install a gaming machine, you will need a certificate from a chamber of industry and commerce confirming that you have received instruction on player and youth protection for machine operators.
Volltext	You need a permit to set up gaming machines. "Setting up" means that you operate a machine and earn money with it, for example in your restaurant. To obtain a permit, you must, among other things, prove that you have attended a training course at the Chamber of Industry and Commerce.
	The training comprises at least six teaching units of 45 minutes each. The Chamber of Industry and Commerce will issue a certificate if you have attended the course without any absences. The training covers the following subjects:
	Trade regulations and gaming regulationsGaming arcade law of the federal statesYouth protection law
	In addition to traders, employees are also required to attend. Office staff and employees with other duties do not require IHK training on the protection of players and minors.
	The training is given in German, so you must have a good knowledge of German.
