If you wish to register as a prostitute, you are obliged to seek advice in advance. If you are already working as a prostitute, you must seek regular advice. Health advice is primarily concerned with topics such as</p> <ul style="list-style-type: none"> <li>• Protection against diseases,</li> <li>• Pregnancy and contraception</li> <li>• risks of alcohol and drug abuse.</li> </ul> <p>The consultation is confidential. This means that no information is passed on. If you do not speak German well, an interpreter or language mediator can be present or can be called to translate for you. Even then, the conversation will remain confidential.</p>
