Teaser	As the operator of a prostitution business, you must notify the competent authority of certain changes.
Volltext	If you operate a prostitution business, you must report certain changes to the competent authority. These include the following changes: • changes to the operating concept, including all changes relating to the type of operation, operating hours or operating premises • personnel changes, including all changes affecting the deputization, management, plant management or supervision of an establishment • changes to company data or the data of the legal representative • Changes to the personal data of the operator The competent authority first checks the changes. If necessary, it will amend your permit to operate a prostitution business accordingly.

- Surname, first name
- Certificate of good conduct for submission to an authority according to document type "0" or European certificate of good conduct
- Identity card, passport or residence permit

In the event of a change in the company data or data of the legal representative:

- the documents and evidence relating to the change

In the event of changes to the personal data of the operating person:

- the documents and evidence relating to the change

In the event of changes to the personal data of persons subject to background checks, such as deputies, managers, supervisors, etc:

- the documents and evidence relating to the change

Voraussetzungen

- You have a valid license to operate a prostitution business.
- The intended changes to the operating concept or to the local location of the operating concept do not conflict with the public interest.
- In the case of personnel changes: personal reliability of the registered person
