| Teaser                           | If you want to establish a business that transports goods by road, you must demonstrate your professional competence.   |
| Volltext                         | You will need this certificate of qualification to apply<br>for a licence for the domestic transportation of goods<br>by road or for an EU licence for the transportation of<br>goods by road within the European Union. As a<br>business operator or transport manager, you must<br>demonstrate that you have the professional expertise<br>required for running a road haulage company.<br>You normally demonstrate this by passing an exam. In<br>Germany, you will sit the exam at your local Chamber<br>of Commerce and Industry (IHK).<br>In the examination, you must prove that you have the<br>required legal and business knowledge, knowledge of<br>technical standards and applicable regulations, and<br>knowledge of road safety. The guidelines for the<br>preparation of the exam contained in the link in the<br>'further information' section provide an overview (in<br>German) of the required knowledge. |

|                          | It is advisable to prepare in depth for the exam, for<br>instance by attending a preparational course or<br>through intense self-study. However, these are not<br>legal requirements for registering for the examination.   |
|                          | The exam is a comprehensive examination consisting<br>of two written parts and one oral part. You must<br>achieve at least 50 percent of the total marks in both of<br>the written parts to be admitted to the oral exam. If<br>you also achieve at least 50 percent of the total marks<br>in the oral exam, and your overall score is at least 60<br>percent of the grand total of marks, you have passed<br>the exam. If you have achieved at least 50 percent of<br>the available marks in both of the written parts and<br>have already achieved at least 60 percent of the grand<br>total of available marks, you are exempted from the<br>oral examination. |
|                          | In certain cases, a transitional arrangement may allow<br>for your professional competence to be certified<br>without sitting the exam. If you have successfully<br>completed a recognised course of vocational training in<br>the freight forwarding and logistics sector which began<br>before 4 December 2011, the Chamber of Commerce<br>and Industry will issue a certificate to you upon request<br>without the need to sit the exam.   |
|                          | If you held a managing position in the freight<br>forwarding industry for ten years or more before 2009,<br>you can also be issued a certificate of professional<br>competence without needing to take the exam. Please<br>refer to the information linked in the 'further<br>information' section.   |
