**Erforderliche Unterlagen**

- Current and expiring permit
  - Application for reissue of the bus and coach permit with details of
    - Surname and first name of the applicant
    - Place of residence and place of business
    - for natural persons: Date of birth, place of birth
    - Number of vehicles, vehicle type, capacity of the vehicles to be used
  - Certificates of employment or certificates of professional competence of the applicant or the person appointed to manage the business
    - Equity certificate, additional certificate if applicable, not older than 3 months
    - Certificate in tax matters from the tax office, the municipality, the social security institutions and the employers' liability insurance association, not older than 3 months:
      - from the company
      - the legal representative
      - the person appointed to manage the business or traffic management)
  - Certificate of good conduct for submission to the authorities
    - Extract from the central trade register
    - Extract from the driving aptitude register (FAER)
    - Vehicle list
    - Proof of liability insurance for buses and coaches including risk identification number (WKZ)
    - Business registration

**Voraussetzungen**

- You are or were already in possession of a bus and coach license as an entrepreneur.
  - You can guarantee the financial capacity of the company.
  - You or the person appointed to manage the business are reliable.
  - You or the person appointed to manage the business are professionally qualified.
  - They have their registered office or branch office in Germany.
