This makes you an equal citizen of the Federal Republic of Germany with all rights and obligations.</p> <p>With German citizenship you can, among other things</p> <ul style="list-style-type: none"> • Exercise your right to vote in the municipalities, in the federal states, in the German Bundestag and in the European Parliament. • Enjoy freedom of movement within the European Union (EU), i.e. <ul style="list-style-type: none"> • move freely within the EU, • be employed or self-employed in the EU and • travel to many countries outside the EU without a visa. <p>If you have been stateless since birth in Germany, you are entitled to naturalization under certain conditions. Voraussetzungen	<ul style="list-style-type: none"> • You must apply for naturalization before the age of 21. • You must <ul style="list-style-type: none"> • be at least 16 years old or • be legally represented. • You have been stateless since birth. • You were born in Germany. • You have been living legally and habitually in Germany for at least 5 years. • You have not been sentenced to a custodial or juvenile sentence of more than 5 years. If you are currently under investigation on suspicion of a criminal offence, the citizenship authority will suspend the naturalization procedure until the proceedings have been concluded.

- Anyone who has been stateless in Germany since birth is entitled to naturalization under certain conditions
 - stateless persons are persons who are not regarded as nationals by any state
 - naturalization confers German citizenship with all rights and obligations
 - German citizenship enables, among other things
 - the right to vote and stand for election in the municipalities, in the federal states, to the German Bundestag and to the European Parliament
 - freedom of movement within the European Union (EU), i.e.
 - move freely within the EU,
 - employed or self-employed in the EU and
 - travel to many countries outside the EU without a visa
