| Teaser                   | If your income or assets are not sufficient to cover your necessary living expenses, you will receive assistance with living expenses (social assistance) under certain conditions.  |
| Volltext                 | As a rule, you will receive assistance with living expenses as a social welfare benefit if you are in need of help and:  |
|                          | <ul> <li>neither basic income support for jobseekers</li> <li>or basic income support in old age and in the event of reduced earning capacity.</li> </ul>  |
|                          | Children under the age of 15 receive social assistance if they:  |
|                          | <ul> <li>live together with people who receive assistance with<br/>living expenses (usually with their parents) and</li> <li>are unable to secure their livelihood despite being<br/>entitled to maintenance.</li> </ul>   |
|                          | The benefits of assistance for living expenses include   |
|                          | <ul> <li>the flat-rate standard rate to ensure subsistence, for example for food, clothing or personal hygiene. A separate standard rate is set for each family member.</li> <li>Education and participation benefits for children and young people, for example for: School trips, personal school supplies, school travel tickets, supplementary learning support, school lunches or club fees, music lessons and the like.</li> <li>Needs for accommodation and heating.</li> <li>In exceptional cases, assumption of debts for: Avoidance of homelessness, secure your accommodation or to remedy a comparable emergency situation, for example debts to the energy supplier.</li> </ul> |

## **Sachverhalt**

• Needs for your health and long-term care insurance contributions and, under certain conditions, for your pension provision.

In addition to your standard rate, you can receive benefits for additional needs for living expenses. You can apply for these additional needs if you:

- meet the requirements for a severely disabled person's pass with the mark "G" and are not able to work under pension law,
- are an expectant mother from the 13th week of pregnancy,
- · are a single parent,
- have reached the age of 15, are disabled and receive assistance for appropriate schooling or training as part of integration assistance,
- are dependent on a special diet due to a medical condition, which leads to higher costs than a "normal" diet.
- produce hot water decentrally (e.g. boiler) rather than through a central heating system, or
- you are a pupil and have expenses for the purchase or loan of school books or equivalent workbooks due to the respective school regulations or school requirements.

If you do not live alone, the social welfare office will take into account the entire family income to determine your need for assistance. For this purpose, the income of all family members living together in the same home is taken into account, for example

- earned income,
- maintenance payments and
- pension income.

Child benefit paid for minors and any maintenance payments for a child are added to the child's needs.

Certain assets are not considered to be protected assets, for example

• smaller amounts of cash (financial assets per adult: EUR 10,000) or

| Verfahrensablauf  | Assistance with living expenses is paid from the moment the social welfare office is informed of the entitlement to benefits. This information is usually provided in the form of an application.   |
|                   | <ul> <li>Arrange a consultation with your local social welfare office. Take all the necessary documents with you to this meeting.</li> <li>Fill out the application for assistance with living expenses during the consultation.</li> <li>The social welfare office will decide on your application and inform you of the result. This will be done in the form of a decision, which is usually sent to you by letter.</li> <li>If your application is approved, you will receive a notice of approval; if it is rejected, you will receive a notice of rejection.</li> <li>In both cases, the notification must contain the reasons for the decision as well as information about the possibility of lodging an appeal. It must also state the deadline within which you can lodge an appeal.</li> <li>The approval notice must also state the amount of the benefit to be paid and the start date of the payment. From the date stated, the social welfare office will transfer the money to your account at the beginning of the month.</li> <li>Please note: You are obliged to inform your social welfare office immediately of any changes to your income and financial circumstances.</li> </ul> |
| Bearbeitungsdauer | Depending on the individual case.   |
| Frist             | The deadlines set by the social welfare office for the submission of documents must be adhered to. If you are unable to do so for understandable reasons, you must apply for an extension of the deadline. Otherwise, the social welfare office may refuse to pay you benefits because you have failed to comply with your statutory obligations to cooperate. This also applies to the appeal deadlines, i.e. if you do not agree with the decision - not only with the rejection decision, but also with the approval decision (amount of the   |

| Kurztext                        | <ul> <li>Subsistence assistance Authorization</li> <li>Persons who are not able to support themselves from their own resources (income and assets) and resources (use of labor) or with the help of others (e.g. parents, children) are entitled to social welfare assistance: are temporarily fully incapacitated for work or unable to work or are expected to stay in an inpatient facility for longer than 6 months or are drawing an old-age pension but have not yet reached the age limit for the standard old-age pension.</li> <li>Benefits for living expenses include the flat-rate standard rate to ensure subsistence, requirements for accommodation and heating, in exceptional cases, assumption of debts in connection with housing and energy, Needs for contributions to health and long-term care insurance and old-age provision, education and participation benefits for children and young people and any additional needs and one-off needs.</li> <li>Calculation basis: Income of all family members (especially parents and children) including maintenance payments or child benefit as well as pension income or earned income</li> <li>certain assets are not taken into account (protected assets), for example small amounts of cash or an appropriate house property</li> <li>apart from a few exceptions: no benefits for past periods (no retroactive benefits)</li> <li>Responsible: local social welfare office</li> </ul> |
