Volltext	<p>Clean air plans exist for areas with poor air quality. Clean air plans contain measures to improve air quality. Environmental zones are one possible measure of such clean air plans. Environmental zones reduce particulate matter and nitrogen dioxide pollution. Vehicles with high pollutant emissions are not allowed to drive in environmental zones.</p> <p>If you want to drive your vehicle in such an environmental zone, you must purchase a fine dust sticker/environmental sticker. The sticker is available in three different colors, each of which is assigned to a pollutant group. The classification of your vehicle into one of the pollutant groups is based on the emission code numbers. You can find these in the vehicle documents.</p>
Erforderliche Unterlagen	Vehicle registration document (for older vehicles) or registration certificate part I (for newer vehicles)
Voraussetzungen	<p>In order to obtain an environmental badge, your vehicle must meet the criteria of pollutant groups 2, 3 or 4.</p> <p>You cannot obtain a sticker for vehicles in pollutant</p>
