Teaser	As a severely disabled person, you can apply for a parking space for severely disabled persons. To do so, you must meet certain requirements.
Volltext	<p>People with severe disabilities have certain rights so that they can be mobile in everyday life. As a severely disabled person, for example, you can apply for a parking space for severely disabled persons at your place of work or residence.</p> <p>To do so, you must meet certain requirements. For example, your severely disabled person's pass must show the mark for an "exceptional walking disability (aG)" or "blind (BL)". In addition, people who suffer from bilateral amelia, the absence of limbs, or phocomelia - hands and feet are located directly on the body - or comparable functional disorders can also apply for this.</p> <p>You can apply for a personal parking space for severely disabled persons informally and only for as long as your severely disabled person's pass is valid. As a rule, this is a maximum of 5 years.</p> <p>The prerequisite is that no suitable parking space is available on private land (e.g. on your own property, tenant's parking space, employer's own parking spaces).</p> <p>Each application is a case-by-case decision. responsible traffic authority approves your application, it will designate the parking space using appropriate markings and signs. The parking space is then exclusively available to you.

The parking space can be set up in a public space or on a private area. In both cases, the parking space must be designated by means of the appropriate traffic signs. In order for such a parking space to be set up on a private area, a corresponding agreement must be in place with the owner of the area.

Erforderliche Unterlagen

- Informal application
- Copy of the front and back of the severely disabled person's ID card with the corresponding features "aG" or "BL"
- In the case of amelia or phocomelia or comparable restrictions, a copy of the assessment notice
- Copy of the registration certificate part 1 and your own or the driver's license of the person driving
- Depending on the application: Certificate from the person renting the vehicle if applying for a parking space in a private area, for example near the place of residence Certificate from the employer if applying for a parking space near the place of work
- Medical certificate stating the reasonable distance, if this is less than 100 meters, and stating the aids such as a rollator or wheelchair
- Reasons why you need the personal parking space; for example, because there are almost never free parking spaces nearby.

Voraussetzungen

- You have at least one of the following disabilities: Exceptional walking disability (mark aG in the severely disabled person's pass) Visual impairment (mark BL in the severely disabled person's pass) bilateral amelia bilateral phocomelia comparable functional disorders
- The special parking right is justifiable, such as in the case of a lack of parking space or unreasonable distance from a garage or parking space outside the public traffic area.
- There are no conflicting traffic regulations in the area, such as a fire department parking area.
