Teaser	If you wish to exhibit animals or make them available for this purpose, you require permission from the responsible authority. You can find out more here.
Volltext	If you wish to exhibit animals or make animals available for this purpose, you require a permit from the competent authority. The term "exhibiting" also includes the carrying of animals for the purpose of collecting donations. The permit relates only to the species and maximum number of animals with which the activity is to be carried out and to the rooms and facilities specified in the application. A permit issued on the basis of incorrect information is invalid and can be revoked at any time.
Erforderliche Unterlagen	• Identity document • Certificate of good conduct • Proof of expertise, certificates • Sketch or construction drawings, plan documents of the premises or facilities
Voraussetzungen	In order to obtain a permit, you generally have to provide proof of your expertise in handling the respective animals and your reliability. In addition, the permit and the requirements are tailored to the individual case. The rooms and facilities used for the activity must enable the animals to be fed, cared for and housed in accordance with the legal requirements.
Kosten	Depends on the administrative fee schedule of the respective federal state.
Verfahrensablauf	If you have applied for a permit, the competent authority will decide on this in a timely manner.
