Teaser	As a winegrower, you must e obtain a planting permit before planting.
Volltext	You must obtain a planting permit before you carry out any planting. If you carry out a planting on an identical vineyard as the previous grubbing-up and the resulting planting potential still exists, the planting is deemed to have been approved. In this case, you do not need to submit an application.
Erforderliche Unterlagen	• Application for authorization to replant vineyards • Application to change the target area (in the case of an existing authorization)
Voraussetzungen	You must have carried out the grubbing up of a vineyard.

Verfahrensablauf	• Before planting a vineyard, submit an application for permission to plant vines. • For the simplified procedure, it is sufficient for you to notify us of the uprooting and planting. • After final processing, you will receive a notification from the competent authority.
Bearbeitungsdauer	0 - 3 Monat(e) If your application is not processed within three months, the vineyard is deemed to have been approved.

Frist	You may only start planting start planting a vineyard once you have received approval. The exception to this is the clearing and planting of the same area, i.e. approval in a simplified procedure.

Hinweise	Planting without an existing decision leads to an unauthorized vineyard area. This is an administrative offense that can be punished.

Kurztext	• Replanting of vineyards Approval • A planting permit is required before any planting. • This requires an application to the competent authority. • Responsible: The respective authority of the federal state.
