Teaser	If your company belongs to the construction industry or an equivalent company and you lose work during the so-called bad weather period, you can partially compensate for your employees' loss of earnings with seasonal short-time allowance.
Volltext	<p>If your construction company is unable to carry out its work due to snowfall, for example, seasonal short-time allowance can partially compensate for the loss of earnings. It is intended to relieve your company and help to preserve jobs.</p> <p>The seasonal short-time allowance is limited to companies</p> <ul style="list-style-type: none"> <li>• the construction industry,</li> <li>• the scaffolding trade,</li> <li>• the roofing trade and</li> <li>• gardening and landscaping.</li> </ul> <p>You can only receive the benefit during the so-called bad weather period from December to March.</p> <p>As an employer, you must apply for, pay and settle the seasonal short-time allowance. Your employees do not have to do anything.</p> <p>Seasonal short-time work can be introduced for your entire company or limited to individual departments.</p> <p>The actual amount of the seasonal short-time allowance depends on the respective income of your employees and the actual loss of work/earnings during the seasonal short-time working period:</p> <ul style="list-style-type: none"> <li>• 60 percent of the lost net wage for employees without a child in the household</li> </ul>

## Sachverhalt

- 67 percent of the lost net wage for employees with at least one child in the household.

In addition to the seasonal short-time allowance, you can apply for additional benefits for your employees, such as the reimbursement of social security contributions.

You receive the seasonal short-time allowance from the first hour of absence.

As an employer, you initially pay wages and salaries to your employees in advance. The short-time working allowance is settled monthly in arrears with the Federal Employment Agency at the payroll office and paid to you retroactively.

## Erforderliche Unterlagen

- Application for seasonal short-time allowance (S-Kug) and supplementary benefits
- Settlement list for seasonal short-time allowance (S-Kug) and supplementary benefits - attachment to the application for benefits

## Voraussetzungen

The seasonal short-time allowance can be applied for in the event of temporary and unavoidable loss of working hours

- for economic reasons or
- for weather-related reasons or
- as a result of an unavoidable event.

Operational requirements:

- Your company belongs to the building trade, scaffolding trade, roofing trade or gardening and landscaping trade.
- Your company or company department employs at least 1 employee.

Personal requirements:

- You have employees subject to social security contributions who have not been dismissed and with whom no termination agreement has been concluded.

Verfahrensablauf	<p>You can apply for seasonal short-time allowance in writing or online. However, you can also use KEA (Kurzarbeitergeld-Dokumente elektronisch annehmen) if necessary.</p> <p>If you want to apply for seasonal short-time allowance in writing:</p> <ul style="list-style-type: none"> <li>• You calculate monthly wage and salary payments as well as the seasonal short-time allowance.</li> <li>• You pay the remuneration for hours worked and the seasonal short-time allowance for hours not worked to your employees and pay the social security contributions.</li> <li>• You apply for reimbursement of the seasonal short-time allowance retroactively each month at the responsible employment agency (application for seasonal short-time allowance and payroll list).</li> <li>• The employment agency checks your application and the payroll list. If your application is approved, you will receive the seasonal short-time allowance. You will receive a written notification.</li> <li>• At the end of the seasonal short-time working period, the Employment Agency will check the statements you have submitted as part of a final audit and, if necessary, correct the approved seasonal short-time allowance.</li> </ul> <p>If you want to apply for seasonal short-time allowance online:</p> <ul style="list-style-type: none"> <li>• Go to the "eServices" portal on the Federal Employment Agency's website.</li> <li>• Log in with your user ID and call up the application for seasonal short-time allowance.</li> <li>• Complete the application, upload the payroll list and submit the application.</li> <li>• The employment agency will check your application and your documents. You will receive notification of the decision on your application from the Employment Agency.</li> <li>• The remaining steps in the procedure are the same</li> </ul>

	<p>as the written procedure.</p> <p>If you wish to use KEA for the application for seasonal short-time allowance and the associated payroll list:</p> <ul style="list-style-type: none"> <li>• You will need certified payroll software that supports transmission using KEA.</li> <li>• In this case, you can transmit your application for seasonal short-time allowance and the corresponding payroll list to the Employment Agency fully digitized and securely from your payroll software.</li> </ul>
Bearbeitungsdauer	<p>0 - 15 Werktag(e)</p> <p>The notification/application is usually processed within 15 working days.</p>
Frist	<p>1 Monat(e)</p> <p>The objection must be submitted to the employment agency that issued the decision within one month of receiving the decision.</p> <p>3 Monat(e)</p> <p>You must submit the application for seasonal short-time allowance within 3 months of the end of the calendar month for which you wish to apply for seasonal short-time allowance.</p>

Kurztext	<ul style="list-style-type: none"> <li>• Seasonal short-time allowance approval</li> <li>• only during the so-called bad weather period from December to March</li> <li>• For companies in the construction, roofing, gardening and landscaping and scaffolding trades</li> <li>• Seasonal short-time allowance is generally paid by the employer to the employees. The employer then applies for reimbursement.</li> <li>• Reimbursement at the earliest from the calendar month in which the loss of working hours was reported</li> </ul>

	<ul style="list-style-type: none"> <li>• Amount depends on the employee's income and the actual loss of work/earnings during the short-time working period</li> <li>• Loss of work is weather-related if it is due to weather conditions and at least 1 hour per day is lost</li> <li>• cyclical short-time working allowance can be applied for before and after the bad weather period</li> <li>• Application by the employer</li> <li>• Responsible: Federal Employment Agency (BA)</li> </ul>
