In cross-border cases, EU law determines which state is responsible for child benefits. This is the case if the family has a connection to several EU states through residence or employment.</li> <li>• you are a legally recognized refugee or person entitled to asylum.</li> </ul> <p>You must apply for child benefit in writing to the responsible family benefits office.
