## Sachverhalt

- Their institution appears on the culture and science map.
- Now contact the service center.
- A cooperation agreement is concluded between the DDB and your institution.
- The DDB sends you a link to an online questionnaire and clarifies questions about data formats and copyright.
- The DDB loads your data into the test system.
- You check the view of the content, then the data is imported into the DDB. The files are published under Creative Commons license.
- If you wish, the DDB will also forward your data to \*\*Europeana.\*\*

You can also use dDB's holdings in external applications (such as websites or mobile apps) unless they are protected by copyright. This allows a wide range of applications to be developed and the data of the DDB to be displayed according to your own wishes.

The integration takes place via the Application Programming Interface (API), a programming interface.

The API is open to all.
