Teaser	From your 27th birthday, you will receive annual pension information from your pension insurance provider if you have paid contributions for a total of at least 5 years. You can also request the pension information informally at any time.
Volltext	<p>The pension information gives you an overview of your accrued entitlements and the amount of retirement pension you can expect. The pension information includes, among other things:</p> <ul style="list-style-type: none"> <li>• a presentation of the contributions you have paid to date,</li> <li>• an indication of the amount of pension entitlements you have acquired, both for a pension due to old age and for a pension due to full reduction in earning capacity, as well as</li> <li>• a projection of your old-age pension entitlements at the time you reach the standard old-age pension.</li> </ul> <p>The extrapolation is based on an average of contributions paid over the last 5 calendar years. This makes the pension information an important basis for planning your additional private and company pension.</p> <p>Together with your first pension information, you will also receive an insurance history. This will show you the periods and earnings stored in your pension insurance account.</p> <p>Pension information is also sent abroad. However, if you live abroad, the automatic mailing will stop if you have not paid any contributions to the German pension insurance for more than 3 years.</p> <p>The amounts stated in the pension information are gross amounts. Health and long-term care insurance contributions and, if applicable, taxes must still be paid from the pension amount stated.</p> <p>In addition, the pension information contains an</p>

Verfahrensablauf	<p>You will automatically receive your pension information by mail each year once you have met the requirements. You do not have to submit an application. However, you can also request pension information informally at any time.</p> <p>If you would like to receive your pension information by mail, you can request it online without further registration:</p> <ul style="list-style-type: none"> <li>• Go to the Deutsche Rentenversicherung website and click on "Online services." Select "Online services without registration" from the drop-down menu and click on "Request insurance documents."</li> <li>• In the "Request from..." field, select.
