Volltext	<p>The pension information contains</p> <ul style="list-style-type: none"> • information about the expected amount of your standard old-age pension, • a forecast of the pension you will receive if you continue to work, • information about the amount of your pension for reduced earning capacity, • information on the earliest possible start date for early retirement pensions, including information on pension deductions, • details of the widow's or widower's pension your partner will receive if you die, • details of contributions paid to date to the statutory pension insurance scheme, • among other things, notes and information on the prerequisites for all old-age pensions, on how to apply for a pension, on additional earnings, on the insurance history, on private old-age provision, on taxation, on information and advice options and on health insurance for pensioners, • if no account clarification has yet been carried out: information on which periods have not yet been clarified (these are periods of which the pension insurance fund does not know whether they can be taken into account for your later pension), • an overview of the saved insurance periods, • an overview of which values and factors were used to calculate your personal earning points and your standard retirement pension. <p>Notice: The pension information is not the same as the pension information (often referred to as "Rentenbescheid"), which you receive every year from the age of 27. The pension information provides very comprehensive information about other pension entitlements. As soon as you are 55 years old, you will</p>

Verfahrensablauf	<p>If you would like to receive pension information by mail:</p> <ul style="list-style-type: none"> • Go to the Deutsche Rentenversicherung website and first click on "Online services" at the top right. • Select "Online services without registration" or go directly to "Request insurance documents". • In the "Request from..." field, select. "Pension information" and enter the remaining data. • Click on "Submit." • You will receive your pension information by mail. <p>If you would like to receive the pension information online:</p> <ul style="list-style-type: none"> • Now go to the Deutsche Rentenversicherung website and click on "Online services" in the upper right-hand corner and then on "Online services with registration." • Follow the instructions to access the online services of the German Pension Insurance. • Alternatively, you can also request the pension information by phone or in writing from your competent pension insurance institution.

Kurztext	<ul style="list-style-type: none"> • Pension information notice • Contains Overview of the stored insurance periods, information about the expected amount of the standard old-age pension and the amount of the reduced earning capacity pension, and Information on the earliest possible pension start date for early retirement pensions. • Can be requested from the pension insurance company at any time • From the age of 55, insured persons automatically receive pension information every 3 years instead of pension information. • Pension information is not identical with pension information ("pension notice"). The pension information is more detailed and contains more information, especially about other old-age pensions. • responsible: German Pension Insurance
