Insofar as changes occur in the nature of your activities, the focus of your overall activity or the legal form of your activity, the obligation to insure must be reviewed. The same applies if you take up additional self-employed activities. Please note that if the artistic or journalistic activity is carried out in the legal form of a legal person or company, this may also have to pay artists' social security contributions.
