Teaser	Has your self-employed artistic or journalistic activity changed in such a way that you no longer carry it out on a professional basis or do you have several employees? Then you can no longer be insured via the artists' social insurance fund.
Volltext	<p>The determination of compulsory insurance under the Artists' Social Insurance Act is always based on the information and documents you have provided on your self-employed artistic or journalistic activity in the determination procedure.</p> <p>If the scope of your activity is reduced or if you employ several people on a dependent basis, the Künstlersozialkasse must check whether your insurance obligation has ended.</p>
