Teaser	If you do not pay your contributions to the Künstlersozialkasse regularly, you will have to pay for your medical treatment yourself.
Volltext	<p>You are obliged to pay your monthly contributions to the statutory health and social care insurance - i.e. the social insurance contributions - to the Künstlersozialkasse (KSK) on time and in full.</p> <p>If you do not pay your contributions punctually and in full, this may result in the benefits of the statutory health and long-term care insurance being suspended. In this case, you will have to pay for almost all medical treatment yourself. There are only a few exceptions.</p>
Erforderliche Unterlagen	No additional documentation is required.
Voraussetzungen	<p>The benefits of the statutory health and long-term care insurance are suspended if</p> <ul style="list-style-type: none"> • you are currently insured for statutory health or nursing care insurance via the KSK, • you have not paid your contributions to statutory health and nursing care insurance for 2 months, and • you still have at least one month's contributions in arrears 2 weeks after the suspension was announced by reminder.
Kosten	There are no costs for you.
Verfahrensablauf	The KSK checks daily whether you pay your

	<p>contributions to the statutory health and long-term care insurance regularly and on time.</p> <ul style="list-style-type: none"> • If you do not pay your contributions in full and on time, the KSK will send you a written reminder. • If you still do not pay your contributions in full, the KSK will check the amount of the arrears in statutory health insurance and social long-term care insurance contributions separately. • If contributions are still outstanding after a further reminder, the so-called suspension reminder, you will receive a notice in which the suspension of benefits is determined. • The KSK will continue to check your contribution payments. • The health and long-term care insurance companies will pay for your medical treatment again as soon as you settle the arrears in contributions and any reminder fees and surcharges for late payment.
Bearbeitungsdauer	Incoming payments are checked daily.
Frist	You must always pay the contributions under the Artists' Social Insurance Act by the 5th day of the following month.

Kurztext	<ul style="list-style-type: none"> • Suspension of benefits from the Künstlersozialkasse after arrears Determination. • Health and nursing care insurance only pay medical or nursing care benefits if insured persons regularly pay contributions. • Arrears of 2 months' contributions will result in suspension of benefits: In this case, insured persons must pay for almost all medical treatment, medication and other services themselves. Health insurance company gives exact information about exceptions • Entitlement to benefits is restored as soon as the arrears in contributions have been settled
