Teaser	<p>You can receive benefits from the Agricultural Employer's Liability Insurance Association (LBG) for farm and household assistance if you are unable to work or require inpatient treatment as a result of an accident at work or occupational disease.</p>
Volltext	<p>You are eligible for LBG farm and household assistance benefits if, as a result of an agricultural work-related accident or occupational disease, you are</p> <ul style="list-style-type: none"> <li>• you are unable to work or</li> <li>• inpatient treatment is necessary.</li> </ul> <p>The Agricultural Employer's Liability Insurance Association ensures that your farm or household continues to operate, thus maintaining your basis of income. The benefits for farm and household assistance essentially cover work that cannot be postponed.</p> <p>For this purpose, the Agricultural Employer's Liability Insurance Association either provides a qualified worker, which is called a "provided worker". Or you procure a replacement yourself.</p> <p>The provided workers can be employees of the SVLFG or employees of other agencies, for example, a machinery ring or a farm relief service.</p> <p>If you procure a replacement yourself, LBG will</p>

reimburse the costs for this to a reasonable amount. Maximum amounts apply. Please note that the costs for relatives and in-laws up to the second degree are not covered. The substitute must also be external to the company, i.e. he or she may not otherwise work in the company or in the household or help out to a significant extent.

In the case of incapacity for work, benefits for company and household assistance are possible for a maximum of 4 weeks, in the case of inpatient treatment for a maximum of 13 weeks. An extension is possible under certain conditions.

- in case of incapacity for work: medical certificate (LBG provides a form for this purpose)

## Voraussetzungen

The Agricultural Employer's Liability Insurance Association (LBG) provides benefits for farm and household assistance if

- you are insured as an agricultural entrepreneur with the LBG,
- you are unable to work or are hospitalized (for example, in a hospital) due to an agricultural accident or occupational disease, and
- the benefits are necessary to ensure the agricultural business or household. The question of necessity is important in deciding whether and to what extent farm and household assistance will be provided.

Farm and household assistance benefits are also available for your or your

- spouse or partner who is an employee of yours.
- life partner.

Activities in non-agricultural parts of the company (subsidiary companies) are excluded from the

Kosten	<p data-bbox="507 367 1005 403">company and household assistance.</p> <p data-bbox="507 434 810 470">No costs are incurred.</p> <p data-bbox="507 510 1222 582">If LBG provides a qualified substitute, it will bear the full costs.</p> <p data-bbox="507 622 1260 1030">If a substitute cannot be provided, LBG will reimburse the costs for an external substitute procured by you to an appropriate amount. The cash benefits actually incurred will be taken into account; benefits in kind, on the other hand, will not be taken into account. Maximum amounts apply to the reimbursement amounts. The following shall be deemed reasonable: the proven expenses up to a daily maximum amount of 2.95 percent of the applicable monthly reference amount, rounded up or down to the next even euro amount.</p> <p data-bbox="507 1039 1267 1187">You must pay a deductible to LBG for each day of service (day of service), regardless of the amount of the expenses incurred. You will be informed of the exact amount in writing.</p>
Verfahrensablauf	<p data-bbox="507 1218 1152 1290">The Agricultural Workers' Compensation Board provides benefits ex officio.</p> <ul style="list-style-type: none"> <li data-bbox="507 1330 1267 1442">• Before starting the assignment of a substitute worker, you must provide LBG with certain information about yourself in the form of a "statement of facts." This is necessary in order to verify the following: <ul style="list-style-type: none"> <li data-bbox="539 1482 1104 1554">• whether you meet the requirements for entitlement to the benefits</li> <li data-bbox="539 1563 1126 1599">• your operational or family circumstances.</li> </ul> </li> <li data-bbox="507 1599 1267 1711">• This notification is not bound to a specific form, but the LBG provides a pre-printed form. You can download this from the LBG website and then fill it out.</li> <li data-bbox="507 1711 1267 1935">• If the benefit is to be paid due to incapacity for work, you must submit a medical certificate. For this purpose, the doctor can use existing forms in the practice; however, the LBG also provides its own form. Please note that you must see a transit doctor after an accident at work or on the way to work.</li> <li data-bbox="507 1935 1241 2007">• Send the documents to the LBG by mail, e-mail, fax or via the SVLFG service portal.</li> <li data-bbox="507 2007 1126 2042">• You will receive the LBG's decision by mail.</li> </ul>
