This includes: occupational accidents commuting accidents and occupational diseases <p>You will also receive death benefits if, for example, there was no funeral due to missing in action. | <p>Voraussetzungen</p> | <p>In order to receive death benefits, the following conditions must be met:</p> <ul style="list-style-type: none"> • Death is the result of an insured event under the agricultural accident insurance, i.e. an accident at work, an accident on the way to work an occupational disease. • You have paid for the funeral. • You are a survivor or survivors. • You are not a survivor or survivors, but you paid for the burial. <p>If you paid for the funeral but are not a survivor or survivors:</p> <ul style="list-style-type: none"> • There are no survivors entitled to the death benefit. |

| <p>Verfahrensablauf</p> | <p>You do not have to apply for the death grant. The Agricultural Employer's Liability Insurance Association examines the claim for death benefits ex officio. The Agricultural Employer's Liability Insurance Association will inform the possible beneficiaries known to it in order to enable them to register their claims. You can still contact the Agricultural Employer's Liability Insurance Association.</p> |

| Kurztext | <ul style="list-style-type: none"> • Death grant from the Agricultural Accident Insurance Grant • Death benefit for Survivors and other persons who have paid for the burial of persons insured by the Agricultural Accident Insurance Fund for accidents • is paid in case of death as a result of an insured event, even if a funeral did not take place, e.g. due to missing in action • Death benefit is paid to survivors who paid for the funeral; if applicable, it is also paid to persons who are not members of the family but who paid for the funeral. • surviving dependents are Widows or widowers, children, stepchildren, foster children, grandchildren, siblings, former spouses and relatives in the ascending line. • Amount is for surviving dependents: one seventh of the reference amount in force at the time of death for the person who paid for the funeral, if there is no survivor: actual amount of the costs of the funeral, up to a maximum of the death benefit for survivors • responsible for insurance cases in agricultural and forestry enterprises: Social Insurance for Agriculture, Forestry and Horticulture (SVLFG) as the Agricultural Employer's Liability Insurance Association (LBG). |
