Volltext	The Federal Office of Administration (BVA) reimburses transport companies in local and long-distance transport for fare losses incurred for the transportation of severely disabled persons and their accompanying persons. • Transport companies • transport associations • Local transport organizations If you have switched from state reimbursement to federal reimbursement, in exceptional cases you can receive an advance payment based on your last final payment notice. You cannot receive advance payments. You must repay the advance payments if you do not submit the required proof by the deadline.
Erforderliche Unterlagen	You do not need to submit any documents.
Voraussetzungen	You can apply for an advance payment if the company entitled to reimbursement has already received a

Verfahrensablauf	You can apply online or by post to the Federal Office of Administration (BVA) for an advance payment for the reimbursement of fare losses on long-distance and local transport: Apply online: • Go to the website of the federal portal and complete the application form for advance payment online. • Submit your application online. Submit an application by post: • Download the application for advance payment from the BVA website. • Complete the application. Print it out and sign it. • Send the signed application by post to the Federal Office of Administration. • You can send the application to the BVA in advance by e-mail for faster processing.

- Reimbursement of fare losses for companies due to the free transportation of severely disabled persons, their accompanying persons, their guide, assistance or assistance dogs and the items they are carrying.
- Reimbursement in the current year in the form of advance payments
- Advance payments amounting to 80 percent of the most recently determined reimbursement amount for fare losses in the current calendar year
 - Transport companies,
 - transport associations (only for local transport) and
 - local transport organizations (only for local transport)
- persons who have already received reimbursements from the Federal Office of Administration can apply for advance payment:
- Applications must be submitted online or by post to the Federal Office of Administration (BVA)
- responsible: Federal Office of Administration (BVA)
