Teaser	If your employees are temporarily working abroad and you want the statutory accident insurance to continue to apply, you usually have to apply for it.
Volltext	Statutory accident insurance offers companies the option of continuing to insure employees even if they are temporarily working abroad. The employees must work abroad for the same company that employs them in Germany. In addition, the duration of the work abroad must be contractually limited from the outset. Your company must submit an application for this. Insurance coverage begins on the day the application is received by the Employer's Liability Insurance Association or the Federal and Railway Accident Insurance. This application is not necessary if insurance coverage already exists under other legal regulations. These include, for example: * Cases in which the so-called "Ausstrahlungsregelung" of the German Social Security Code applies. * regulations under European law * social security agreements between 2 or more countries

- * Foreign insurance with statutory accident insurance Confirmation
- * If legal regulations do not apply, foreign insurance can be taken out.
- * Legal regulations include, for example:
 - * if the so-called radiation regulation of the social security code applies,
 - * European law regulations or
 - * social security agreements exist between 2 or more countries.
- * Statutory accident insurance coverage continues to apply in the case of temporary work abroad if
 - * employers' liability insurance association or accident insurance fund offers insurance abroad
 - * Application required
 - * Persons who live directly abroad and have only been hired there (local employees) cannot be insured through a foreign insurance policy.
 - * Exception: Berufsgenossenschaft der Bauwirtschaft (BG BAU) allows insurance of the person hired abroad in individual cases.
 - * insurance coverage is valid from the day after receipt of the application
 - * no retroactive insurance coverage
 - * Application required separately for each insured person
 - * Application online or by mail
 - * Costs: none
 - * Processing time: 1 to 2 weeks
 - * responsible:
 - * for commercial companies: Employer's Liability Insurance Associations (classified by industry)
 - * for public companies: Federal and railroad accident insurance
