Teaser	If your earning capacity is reduced by 40 percent or more, you can receive a sum of money as a settlement for a period of 10 years instead of the accident pension upon application
Volltext	If your earning capacity is reduced by 40 percent or more, you may apply for a settlement limited to a maximum of 10 years. The same applies if you are entitled to several pensions that together equal or exceed 40 percent reduction in earning capacity. You will be paid 9 times the annual amount of the pension on which the settlement is based as a settlement. The portion of the pension not settled will continue to be paid monthly. At the end of the 10 years, you will then again be paid the entire pension in monthly installments. If your health deteriorates after you have been granted a settlement, your entitlement to the pension will be revived in full upon application. The settlement amount paid will be offset against your pension.
Erforderliche Unterlagen	You do not need to submit any documents.

Voraussetzungen	You are entitled to a pension settlement if: • you have reached the age of 18 • you are either receiving a pension for an indefinite period after a reduction in your earning capacity of 40 percent or more • or you receive several pensions that together equal or exceed 40 percent reduction in earning capacity • the reduction in earning capacity is not expected to decrease significantly within the settlement period • you have enough left to live on without the pension

Verfahrensablauf	You can apply online or by mail for settlement of an accident insurance pension for a reduction in earning capacity of at least 40 percent. Online service: • Access the online service. • You will be guided through the process on the Accident Insurance Service Portal. • You can log in. • If you would like to receive the response from your employers' liability insurance association or accident insurance fund in the mailbox of your BundID account or My Company Account, you must have an account and authenticate yourself. • If you would like to receive the response by mail, you can also proceed without logging in. • Select your responsible employers' liability insurance association or accident insurance fund or determine it using the industry search. • Upload the required documents. • Fill out the online form and submit it. • Your report will automatically be forwarded to your employers' liability insurance association or accident insurance fund. • You will receive a response via the requested channel.

- 9 times the annual amount of the pension on which the severance payment is based.
- part of the pension, which is replaced by the settlement, expires at the end of the month of payment for a period of 10 years
- Revival of the entitlement:
 - the part of the pension which has been settled shall be revived ex officio after 10 years
 - pension adjustments and pension increases as well as any aggravations are also taken into account ex officio during the resumption of entitlement
