Volltext	**Data protection and online privacy** EU data protection rules guarantee the protection of your personal data whenever they are collected - for example, when you buy something online, apply for a job, or request a bank loan. These rules **apply to both companies and organisations (public and private) in the EU and those based outside the EU who offer goods or services in the EU** , such as Facebook or Amazon, whenever these companies request or re-use the personal data of individuals in the EU. It doesn't matter what format the data takes - online on a computer system or on paper in a structured file - whenever information directly or indirectly identifying you as an individual is stored or processed, **your data protection rights have to be respected**.
