Teaser	When you set up a business in Germany, you must comply with certain rules and requirements. This section provides information on your rights and obligations, in particular relating to corporate finance.
Volltext	**Financing options for businesses** In Germany, **various financing options** are offered to companies at the national level. The first port of call for businesses looking for financing options is the **Förderdatenbank (funding database)**, which is made available by the Federal Ministry for Economic Affairs. The financing options contained in the funding database include all those managed by the development bank KfW. **Who can participate in the funding programmes?** By means of a **user-friendly filtering option**, you can use the funding database to find suitable financing options for businesses at a national level. To that end, filter for **Unternehmen (businesses)** under Förderberechtigte (funding recipients) and for **Bund (Federal Government)** under Fördergeber (funding providers). You will be shown **275 funding programmes** that match your search. Which businesses are eligible for one or more of the 275 funding programmes **varies according to the selected funding programme** **and the individual situation of the business.** In addition, it is also possible to search for **funding organisations** using your address details, such as your town or postcode. **Who is responsible for managing the

programmes?**

Depending on the funding programme, **different institutions** are responsible for management. The database contains more than 2 000 funding organisations.

You will find **more detailed information** on the funding provider and the point of contact directly **in the** **funding database** by clicking on a funding programme.

How can you apply?

The application process for financing **varies depending on the funding programme**. Details can be found directly in the section featuring the financing option or funding programme you have selected on the funding database and/or under the links indicated there.

Make use of your right to information

You can require the banks to provide information about the credit decision. This will allow you to **better assess your financial position** and **improve** your **chances** of financing. Make use of your right by referring to [Article 431 of the EU Capital Requirements Regulation](https://eur-lex.europa.eu/legal-content/EN/TXT/?uri=celex%3A32013R0575) of 2013.
