Volltext	The European Union (EU) can support agricultural market prices by granting subsidies for the private storage of butter. This supports you as a market participant in crises in the dairy sector.
	Once you have concluded a contract with the Federal Office for Agriculture and Food (BLE) for private storage and the contractual storage period ends, you can apply for the aid from the BLE.
