Teaser	If you distribute butter, you can sell goods for transfer to public storage for reasons of market support. To do this, submit an offer to the Federal Office for Agriculture and Food (BLE).
Volltext	The European Commission buys and stores butter to support agricultural market prices. As a market participant, you benefit from this market support measure during crises in the dairy sector. In the period from February 1st to September 30th of each year, you can offer butter to the Federal Office for Agriculture and Food (BLE) for purchase at an intervention price of 90 percent of the reference price and for transfer to public storage.

Alternatively, you can print out the completed form and send it to the BLE by post with the required documents.</li> <li>The BLE will check your offer and contact you if anything is unclear or information is missing.</li> <li>The BLE will send you a confirmation of the offer or a rejection.</li> </ul>
	Submit your offer by fax or post:
	<ul> <li>Download the offer form and the security form from the BLE website. Note: Forms are only available on the BLE website if there is an EU intervention directive.</li> <li>Complete the forms.</li> <li>Send them to the BLE by fax or post together with any necessary documents.</li> <li>The BLE will check your offer and contact you if anything is unclear or information is missing.</li> <li>The BLE will send you a confirmation of the offer or a rejection.</li> </ul>
