| Teaser                   | If you are unemployed and want to start your own business, you are entitled to financial support.  |
| Volltext                 | A start-up grant, or "Gründungszuschuss", is intended<br>to help you with your living costs and guarantee social<br>security benefits if you set up your own business. You<br>are only entitled to a start-up grant if there are no<br>other suitable job openings for you and if you want to<br>be self-employed as your main occupation.<br>Before applying for a start-up grant, you must be<br>registered as unemployed. You are not eligible for the<br>grant if you are entering self-employment straight from<br>a job. There are two start-up grant equal to the last<br>unemployment benefit received for living costs plus a<br>monthly lump sum of EUR 300 for social security<br>• Phase 2: a 9-month grant of EUR 300 a month<br>After phase 1, you may be able to receive a start-up<br>grant for a further 9 months. This will be decided on an<br>individual basis.<br>The start-up grant will not be subject to income tax<br>however much you earn on top of it.<br>You cannot apply for funding if you are eligible for a<br>state pension.<br>You can apply for the grant in addition to other funding<br>for self-employment. There is no legal entitlement to<br>the start-up grant. |

| Voraussetzungen  | <ul> <li>You are in receipt of unemployment benefit I.</li> <li>You are still entitled to at least another 150 days of<br/>unemployment benefit upon becoming self-employed.</li> <li>You are able to prove that you have the knowledge<br/>and skills to pursue the activity in a self-employed<br/>capacity.</li> <li>You can provide a favourable opinion from a<br/>professional body on the viability of setting up as<br/>self-employed.</li> <li>The Employment Agency (Agentur für Arbeit) was<br/>unable to find a suitable opening for you on the job<br/>market.</li> <li>You are not eligible for a state pension.</li> </ul> |

| Verfahrensablauf | <ul> <li>You must apply for the start-up grant through the Employment Agency:</li> <li>Make an appointment with the Employment Agency.</li> <li>Your adviser will tell you what financial support is available if you are setting up as self-employed and what conditions you need to meet.</li> <li>You will then need a professional body to issue a favourable opinion on your start-up project. You can choose which one to use. Competent professional</li> </ul>  |
