- personal data.

The eAT comprises the following residence permits:

- Residence permit
 - Settlement permit
 - Permit for permanent residence-EU
 - Residence card for third-country nationals who are family members of nationals of an EU or EEA country
 - Permanent residence card for third-country nationals who are family members of EU or EEA nationals
 - Residence permit for Swiss citizens and their family members from third countries, if they opt for an eAT

- a biometric photograph

The residence permit must be valid for at least one month.

Verfahrensablauf	You can use the electronic residence title like the new identity card for German citizens. Detailed information on the electronic use of the card can be found on the website of the Federal Office for Migration and Refugees. You must apply for the electronic residence permit in person at the competent authority. It captures your fingerprints on site. Children aged 6 and over must also give their fingerprints.
