Volltext	If young people between the ages of 14 and 18 or young adults up to the age of 21 have come into conflict with the law, they and their parents can turn to youth welfare services in criminal proceedings. Youth welfare in criminal proceedings is one of the statutory tasks of the Youth Welfare Office. It is involved in the entire process of juvenile court proceedings. In doing so, it accompanies young delinquents, but also supports the juvenile courts and the juvenile prosecutor's office with reports, statements and decision-making aids. In all considerations, the personal life situation of the young person is in the foreground. Tasks of youth welfare services in criminal proceedings: The diverse tasks of youth welfare services in criminal proceedings include in particular: Information and advice • on the course of juvenile court proceedings, • the possible consequences of the offence, • Data protection and protection of legitimate expectations, • various offers of assistance in accordance with the Child and Youth Welfare Act, • in case of problems and difficulties in school, profession and training, Family and Living, Leisure time as well as at Owe; Reporting to the public prosecutor's office and the juvenile court (in each case taking into account proportionality) in written form on
