### Volltext

Do you have foreign citizenship and would like to work in Germany? Then you need

- a residence permit for the purpose of employment and previously

- in most cases, a national visa to enter Germany.

Citizens of Australia, Israel, Japan, Canada, New Zealand, South Korea and the United States of America may obtain the required residence permit even after entering the country. The competent authority is the foreigners' authority of the place where the foreigner will take up residence in Germany.

The residence permit for the purpose of employment is temporary. You can have it extended on request.

### Erforderliche Unterlagen

- Proof of compliance with passport and visa requirements
- Proof of secure livelihood
- Proof that you meet the factual and personal requirements for labour migration
- Proof of job or job offer
- Proof that there are no grounds for expulsion against you
- Proof that you do not endanger or impair the interests of the Federal Republic of Germany

### Voraussetzungen

Requirements for the residence permit are:

- They meet the passport and visa requirements.
  - Income in the amount of the simple standard rate of social assistance plus
    - costs for accommodation and heating as well as
    - of any health insurance contributions.
- Your livelihood is secured without using public funds.
- There is no ground for expulsion against you.
- Your stay does not endanger or impair the interests of the Federal Republic of Germany.
- They meet the factual and personal requirements for labour migration.
- You have a job or a specific job offer.
- The Federal Employment Agency approves the issuance of the residence permit.

Both for new arrivals and for third-country nationals

who already have their domicile or habitual residence in Germany, the approval of the Central Employment Service of the Job Agency is generally required to take up employment in Germany. It is obtained in an internal procedure by the competent immigration authority. Therefore, only an application to the competent immigration authority is required.

Consent shall normally be given if:

- a legal provision grants access to the German labour market,
- employment does not adversely affect the labour market;
- preferred employees (Germans, EU citizens, citizens from EEA states) are not available (so-called priority check),
- the foreigners are not employed under less favourable working conditions than comparable German employees.

The consent may be subject to restrictions on professional activity, the employer, the district of the Employment Agency, the location and distribution of working hours, which can be found in the residence permit.

According to the new Integration Act, the priority check will be suspended for a limited period of three years for asylum seekers and tolerated persons, thus also enabling them to work in temporary work. In order to avoid possible negative effects in regions with a tense labour market situation, the federal states should determine for themselves in which employment agency districts the regulation applies.

Since 01.09.2011 you will receive the residence title in the form of a credit card with additional electronic functions.
