Volltext	A license to practice can be granted for entry in the Register of Craftsmen in accordance with § 7b HwO if relevant training has been completed and at least 6 years of work as a journeyman including at least 4 years in a managerial position in the craft applied for or a related craft.	
	Once you have been granted a license to practice, you meet the registration requirements for a craft requiring a license in the register of craftsmen. A license does not entitle you to hold the title of master craftsman or to train in the relevant craft. Tip: The trades requiring registration are listed in Annex A of the Crafts Code.	
	Please note: The following trades requiring a license are excluded from these regulations: chimney sweeps, opticians, hearing aid acousticians, orthopaedic technicians, orthopaedic shoemakers and dental technicians. - https://www.gesetze-im-internet.de/hwo/anlage_a.html - https://www.gesetze-im-internet.de/hwo/anlage_a.html
