You should have professional experience in the field of taxes administered by the federal and state tax authorities.</p> <p>These include:</p> <ul style="list-style-type: none"> <li>• Professors who have taught at a German university for at least 10 years in the relevant field,</li> <li>• former tax judges who have worked in this field for at least 10 years,</li> <li>• former civil servants of the higher service and comparable employees of the financial administration who have worked in the relevant field for at least 10 years,</li> <li>• former senior civil servants and comparable employees of the tax administration who have worked in the relevant field for at least 15 years</li> </ul>
