Volltext	Do you need information on whether insolvency proceedings have been opened against a natural or legal person or would you like to find out about the status of ongoing proceedings? On the nationwide Internet portal , the courts publish notices on insolvency proceedings. The portal contains public announcements on insolvency proceedings concerning, for example: • the ordering and annulment of precautionary measures by the court; • the rejection of an insolvency application for lack of assets, • the decision to open insolvency proceedings, • the decision to terminate or close insolvency proceedings; • resolutions on the determination of the remuneration of the insolvency administrator, the trustee and the members of the creditors' committee, • Deadlines, • Decisions on discharge of residual debt findable. On the page you will find the insolvency notices of all German insolvency courts.
Erforderliche Unterlagen	For the online search you do not need any documents or proofs.

Kosten	The information provided by the insolvency court is free of charge.
Verfahrensablauf	The free search in the nationwide Internet portal is possible by entering search criteria. The results corresponding to the search criteria on generally accessible information on insolvency proceedings are then displayed in list form.
