	• does not comply with the insurance obligation to conclude or maintain the private long-term care insurance contract pursuant to § 23.1 sentences 1 and 2 SGB XI or § 23.4 SGB XI or the obligation to maintain the private long-term care insurance contract pursuant to § 22.1 sentence 2 SGB XI, and • is in arrears with the payment of 6 monthly premiums for private long-term care insurance. The administrative offence can be punished with a fine of up to 2,500.00 euros.
