There is no legal entitlement to funding.

Voraussetzungen	The application must demonstrate that the situation of disabled sports in Hesse will be sustainably improved.

Verfahrensablauf	Submission of an informal application to the Hessian Ministry for Family Affairs, Senior Citizens, Sport, Health and Care. This must be accompanied by a detailed project description and a cost and financing plan. The cost and financing plan must show the expected costs, the planned forms and any commitments already made to finance the project (own funds, third-party funds). The application will be subject to a sports-related review by the Hessian Ministry for Family Affairs, Senior Citizens, Sport, Health and Care.
