Depending on the desired qualification, the doctor will take an exam for this purpose and will receive a certificate after passing it.
Erforderliche Unterlagen	Continuing education certificates, attachments to the certificate in certified copy with associated employment contracts in simple copy. Required certificates accordingly. Voraussetzungen	Medical license to practice medicine or corresponding § 10 professional license according to the Federal Medical Code.
