The term "legitimate interest" here includes any interest of a legal, economic or non-material nature that can be recognized as worthy of protection.</li> <li>• The person you are looking for is clearly identified by the information you provide.</li> <li>• No information block is entered in the register of residents and there are no indications that the person(s) sought or another person may be at risk of having their interests protected by the provision of information.</li> </ul>
