Teaser	If you start a business, participate in a business or become self-employed, you must inform the tax office.
Volltext	Companies and the self-employed must also take care of the tax in the start-up phase. In order for the tax office to be able to classify you correctly in the tax, it needs certain information about your company or self-employment. This information must be provided in the "Tax Registration Questionnaire". You must submit this questionnaire to the tax administration within one month without individual request from your local tax office via the online procedure, for example via the free online platform "Mein ELSTER" (www.elster.de). After a corresponding check of the information, you will be issued a tax number, which is, among other things, a prerequisite for accounting. With the help of this questionnaire, the tax office also determines, among other things,
	 determines, among other things, which types of taxes you have to pay, when you have to pay, how much you are expected to have to pay. As a result, your information in the questionnaire for tax registration forms the basis for all correspondence relating to your company or your self-employment with

Note: If you do not yet have an ELSTER user account, you can register free of charge at www.elster.de a) One possibility is to register only by means of an e-mail address. It should be noted that with this created certificate, only the transmission of the questionnaire for tax registration is permitted. However, this e-mail certificate can be converted into a
