Teaser	You can have your residence permit extended for the purpose of studying before the expiry of its period of validity if you meet certain conditions for this purpose.
Volltext	<p>The residence permit for the purpose of studying is a temporary residence permit. You can apply for an extension of your residence permit if you have not yet completed your studies but can still obtain it within a reasonable period of time. For the duration of stay, a stay of ten years is usually the upper limit.</p> <p>When deciding on the extension of a residence permit for the purpose of studying, the Foreigners' Registration Office may obtain and take into account opinions from the university or other institutions admitted to education or training in questions of study requirements, the course of study, the degree and other academic matters.</p> <p>The same conditions apply to the extension of the residence permit for the purpose of studying as to the grant. In particular, your livelihood should be secured for the duration of your studies.</p>

## Sachverhalt

In the event of an extension, your residence permit will be limited again. The residence permit for the purpose of studying is extended by at least one year and usually by two years or for the remaining duration of the studies.

If the foreigner participates in a Union or multilateral programme with mobility measures (e.g. ERASMUS+ programme of the European Union) or if the foreigner is covered by an agreement between two or more higher education institutions, the residence permit is extended for at least two years. If the course lasts less than two years, it is extended by its duration.

As a rule, the residence permit cannot be extended if this has already been excluded when the residence permit was issued or last extended

## Erforderliche Unterlagen

- Passport or passport substitute
- Current biometric photo
- Existing residence permit
- Proof of subsistence (e.g. blocked account at a German bank, scholarship certificate or declaration of commitment)
- Proof of your health insurance
- If applicable, proof of achievements in the course of study
- Lease

## Voraussetzungen

- You have a recognised and valid passport or passport substitute as well as a valid residence permit for the purpose of studying in accordance with § 16b paragraph 1 of the Residence Act.
- The validity period of your residence permit will expire in the near future.
- There is no interest in expulsion against you.
- Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany
- They have not yet completed their studies and can prove that they can achieve it within a reasonable period of time.
- Your livelihood is secured for the entire duration of your studies.

Verfahrensablauf	<p>The extension of your residence permit must be applied for at the immigration authority responsible for your place of residence.</p> <ul style="list-style-type: none"> <li>• Depending on the immigration authority and concerns, it may be possible to apply via the Internet. Find out whether your immigration authority offers the electronic application for a residence permit.</li> <li>• If the application is only possible in person, please arrange an appointment with the Foreigners' Registration Office.</li> <li>• During the appointment, your application will be received and your supporting documents will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuance of the electronic residence permit (eAT).</li> <li>• In the event of an electronic application, the Foreigners' Registration Office will contact you after receipt of your online application in order to arrange an appointment at the Foreigners' Registration Office. During the appointment, your proof will be checked (please bring it with you to the appointment) and your fingerprints will be taken for the issuance of the eAT card.</li> <li>• If your application is granted, the Foreigners' Registration Office will arrange for the eAT card to be produced.</li> <li>• After about six to eight weeks, you can pick up the eAT card at the Foreigners' Registration Office.</li> <li>• Fees apply for the extension of the residence permit. The timing and form of payment vary depending on the authority</li> </ul>

Kurztext	<ul style="list-style-type: none"> <li>• Residence permit for the purpose of training</li> <li>Extension for study preparation and studies</li> <li>• Residence permit for the purpose of studying is extended if its validity expires in the near future and the studies in Germany are to be continued beyond their period of validity.</li> <li>• The extension must be applied for no later than eight weeks before the expiry of the time limit.</li> <li>• An extension of the residence permit for the purpose of studying is only possible if the requirements that were met when it was first issued are still met.</li> <li>• When extended, the residence permit is again limited.</li> <li>• An extension is excluded if the degree cannot be completed within a reasonable period of time or if the extension has already been excluded by the Foreigners' Registration Office when it was granted or the last extension.</li> <li>• Depending on the immigration authority and concerns, the application is possible via the Internet or only in person.</li> <li>• Renewal fees apply.
