Teaser	You can have your residence permit extended for the purpose of studying before the expiry of its period of validity if you meet certain conditions for this purpose.
Volltext	The residence permit for the purpose of studying is a temporary residence permit. You can apply for an extension of your residence permit if you have not yet completed your studies but can still obtain it within a reasonable period of time. For the duration of stay, a stay of ten years is usually the upper limit. When deciding on the extension of a residence permit for the purpose of studying, the Foreigners' Registration Office may obtain and take into account opinions from the university or other institutions admitted to education or training in questions of study requirements, the course of study, the degree and other academic matters.

	In the event of an extension, your residence permit will be limited again. The residence permit for the purpose of studying is extended by at least one year and usually by two years or for the remaining duration of the studies.
	If the foreigner participates in a Union or multilateral programme with mobility measures (e.g. ERASMUS+ programme of the European Union) or if the foreigner is covered by an agreement between two or more higher education institutions, the residence permit is extended for at least two years. If the course lasts less than two years, it is extended by its duration. As a rule, the residence permit cannot be extended if
	this has already been excluded when the residence permit was issued or last extended

Kurztext	 Residence permit for the purpose of training Extension for study preparation and studies Residence permit for the purpose of studying is extended if its validity expires in the near future and the studies in Germany are to be continued beyond their period of validity. The extension must be applied for no later than eight weeks before the expiry of the time limit. An extension of the residence permit for the purpose of studying is only possible if the requirements that were met when it was first issued are still met. When extended, the residence permit is again limited. An extension is excluded if the degree cannot be completed within a reasonable period of time or if the extension has already been excluded by the Foreigners' Registration Office when it was granted or the last extension. Depending on the immigration authority and concerns, the application is possible via the Internet or only in person. Renewal fees apply.
