Teaser	You can have your residence permit extended for the purpose of carrying out a qualification measure for the purpose of recognising your foreign professional qualification before the expiry of its period of validity if you meet certain conditions for this
Volltext	The residence permit for carrying out a qualification measure is a temporary residence permit. You can apply for an extension of your residence permit if the qualification measure(s) has not yet compensated for the deficits of foreign qualifications, e.g. because you have to repeat an examination or because the examinations are preceded by long waiting times.  The same conditions apply to the extension of the residence permit for the purpose of carrying out a qualification measure as for the grant. In particular, your livelihood should be secured for the entire duration of the qualification measure(s).  In the event of an extension, your residence permit will be limited again. The residence permit for the purpose of carrying out a qualification measure may be extended by six months. However, the total duration of

	stay for the purpose of carrying out the qualification measures may not exceed two years.  As a rule, the residence permit cannot be extended if
	this was already excluded when the residence permit was issued or last extended.

Voraussetzungen	<ul> <li>You have a recognised and valid passport or passport substitute as well as a valid residence permit for the purpose of carrying out a qualification measure for the purpose of recognising your foreign professional qualification in accordance with Section 16d (1) of the Residence Act.</li> <li>The validity period of your residence permit will expire in the near future.</li> <li>There is no interest in expulsion against you.</li> <li>Your stay does not endanger or adversely affect the interests of the Federal Republic of Germany</li> <li>The qualification measure is still suitable to enable the recognition of the professional qualification or access to the profession.</li> <li>Their livelihood is secured.</li> </ul>
Kosten	<ul> <li>Extension of the residence permit for the implementation of a qualification measure for the recognition of foreign professional qualifications: for a further stay of up to three months: EUR 96 for a further stay of more than three months: EUR 93</li> <li>Under certain conditions, a fee reduction or exemption may be considered.</li> </ul>
Verfahrensablauf	The extension of your residence permit must be applied for at the immigration authority responsible for your place of residence.  • Depending on the immigration authority and concerns, it may be possible to apply via the Internet.

	Find out whether your immigration authority offers the electronic application for a residence permit.  • If the application is only possible in person, please arrange an appointment with the Foreigners' Registration Office.  • During the appointment, your application will be received and your supporting documents will be checked (please bring them with you to the appointment). Your fingerprints will be taken for the issuance of the electronic residence permit (eAT).  • In the event of an electronic application, the Foreigners' Registration Office will contact you after receipt of your online application in order to arrange an appointment at the Foreigners' Registration Office. During the appointment, your proof will be checked (please bring it with you to the appointment) and your fingerprints will be taken for the issuance of the eAT card.  • If your application is granted, the Foreigners' Registration Office will arrange for the eAT card to be produced.  • After about six to eight weeks, you can pick up the eAT card at the Foreigners' Registration Office.  • Fees apply for the extension of the residence permit. The timing and form of payment vary depending on the authority

	validity expires in the near future but the qualification measures have not yet compensated for the deficits of the foreign qualification identified.  • The extension must be applied for no later than eight weeks before the expiry of the time limit.  • An extension of the residence permit for the purpose of carrying out a qualification measure is only possible if the conditions that were met when it was first issued continue to be met.  • Upon renewal, the residence permit is again limited in time  • The extension is excluded if the extension has already been excluded by the Foreigners' Registration Office when it was granted or the last extension.  • Depending on the immigration authority and concerns, the application is possible via the Internet or only in person.  • Renewal fees apply. The timing and form of payment vary depending on the authority  • Responsible: the immigration authority responsible for the applicant's place of residence
