Teaser	As a skilled worker with vocational training, you can obtain a residence permit for qualified employment if you meet certain requirements.
Volltext	You can obtain a residence permit for skilled workers with vocational training if you have completed qualified vocational training in Germany. A qualified vocational training exists if you have completed vocational training in a state-recognised or comparably regulated training occupation. The training period must have been at least two years. If you have completed your vocational training abroad, the equivalence of your qualification with the German, qualified vocational training must be determined by the responsible recognition body (e.g. the Chamber of Industry or Commerce).

	Before the residence permit is issued, the Federal Employment Agency must agree. This Federal Employment Agency checks whether the working conditions correspond to those of comparable German employees, whether you are in employment for which your qualifications qualify you and whether you have a domestic employment relationship. If the residence permit is issued, it is limited in time. The validity depends on your employment contract or the period of validity of the approval of the Federal Employment Agency. In the case of permanent employment contracts, the residence permit for skilled workers is issued for a period of four years.

Voraussetzungen	<ul> <li>You have a recognized and valid passport or passport substitute and - if required for entry - an appropriate visa.</li> <li>There is no interest in expulsion against you.</li> </ul>

#### Sachverhalt

 Your stay does not endanger or impair the interests of the Federal Republic of Germany.

You have:

· qualified vocational training in Germany or

• an equivalent foreign professional qualification • a qualification that enables you to pursue qualified employment. This means that, in principle, you can also work in a related profession if there is a connection between your training and the intended activity (e.g. a baker can also work as a confectioner).

• You have a job or a job offer

	<ul> <li>If you have reached the age of 45, you must prove an employment contract or a binding job offer with a certain minimum salary. The minimum salary must reach 55 percent of the annual contribution assessment ceiling in the general pension insurance. Even if this minimum salary is not reached, a residence permit may be issued on presentation of proof of adequate retirement provision or in special cases (e.g. if there is a public interest in employment). The amount of the contribution assessment ceiling is announced for each year by 31 December of the previous year by the Federal Ministry of the Interior, Building and Community in the Federal Gazette.</li> <li>The Federal Employment Agency has approved the commencement of work (consent is usually obtained from the Foreigners' Registration Office). For approval, inter alia, their working conditions (in particular salary) be comparable to those of a German employee in the same position.</li> <li>If required, you have a professional license.</li> </ul>
Kosten	Gebühr: 100€ Under certain conditions, a fee reduction or exemption may be considered.
Verfahrensablauf	The residence permit must be applied for at the immigration authority responsible for your place of

	residence. The procedure is as follows:
	<ul> <li>Depending on the immigration authority and concerns, it may be possible to apply via the Internet. Find out whether your immigration authority offers the electronic application for a residence permit.</li> <li>If the application is only possible in person, make an appointment with the Foreigners' Registration Office. During the appointment, your application will be received and your supporting documents will be checked (bring them with you to the appointment). Your fingerprints will be taken to produce an electronic residence permit (eAT card).</li> <li>In the event of an electronic application, the Foreigners' Registration Office will contact you upon receipt of your online application in order to make an appointment at the Foreigners' Registration Office if necessary. During the appointment, your documents will be checked (bring them with you to the appointment) and your fingerprints will be taken for the production of the electronic residence title (eAT card).</li> <li>If your application is granted, the Foreigners' Registration Office will arrange for the eAT card to be produced.</li> <li>After about six to eight weeks, you can pick up the eAT card at the Foreigners' Registration Office.</li> <li>The eAT card must always be picked up in person.</li> <li>Fees apply for the issuance of the residence permit. The timing and form of payment vary depending on the authority.</li> </ul>

Frist	• The residence permit should be applied for at least eight weeks before the expiry of your valid visa or residence permit. • The residence permit is issued for a limited period. The validity depends on the duration of your employment contract and the approval of the Federal Employment Agency. • Opposition period: 1 month

Kurztext	<ul> <li>Residence permit for the purpose of gainful employment Issue for the purpose of employment in qualified employment as a skilled worker with vocational training</li> <li>Foreigners who have a German or equivalent, foreign qualified vocational training can obtain a residence permit for the purpose of exercising qualified employment.</li> <li>The Federal Employment Agency must approve the issuance of the residence permit.</li> <li>The residence permit is issued for a limited period. The period of validity depends on the employment contract or the approval of the Federal Employment Agency. In the case of permanent employment contracts, the residence permit for skilled workers is issued for a period of four years.</li> <li>Holders of a residence permit for the purpose of qualified employment can obtain a settlement permit after fulfilling certain conditions</li> <li>Spouses of holders of residence permits for the purpose of skilled employment are also entitled to a residence permit.</li> <li>Depending on the immigration authority and concerns, the application is possible via the Internet or in person.</li> <li>There is a fee for the issuance of the residence permit. The timing and form of payment vary depending on the authority.</li> <li>Responsible: the immigration authority responsible for the applicant's place of residence;</li> </ul>
